WHEREAS, Ordinance No. 72-A-9 (Earned Income Tax) and Ordinance No. 74-A-9 (Deed Transfer Tax) were duly enacted and

WHEREAS, PURSUANT TO THE "Local Tax Enabling Act" of December 31, 1965, P. L. 1257. Section 4, as amended October 9, 1967, Act. No. 160, Section 1: Every such tax shall continue in force on a calendar or fiscal year basis, as the case may be, without annual re-enactment unless the rate of tax is subsequently changed; and the Board of Commissioners of the Township of South Fayette desires to continue said ordinances in force for the year 2010 exactly the same as they were enacted for the year 2009;


NOW, THEREFORE, it is hereby resolved that the above Ordinances are reenacted automatically for the year 2010 pursuant to the "Local Tax Enabling Act", as amended.




