RESOLUTION NO. 17 OF 2021

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE, ALLEGHENY COUNTY, PENNSYLVANIA, CONFIRMING THEIR COOPERATION WITH THE SOUTH FAYETTE TOWNSHIP MUNICIPAL AUTHORITY RELATIVE TO THE ENTRY INTO AN ADMINISTRATIVE CONSENT ORDER WITH THE ALLEGHENY COUNTY HEALTH DEPARTMENT WITH RESPECT TO THE SANITARY SEWER SYSTEM SERVICING THE TOWNSHIP OF SOUTH FAYETTE.

WHEREAS, the South Fayette Township Municipal Authority ("Municipal Authority") owns and operates the sanitary sewer system within the Township of South Fayette ("Township"); and

WHEREAS, the Allegheny County Health Department ("ACHD") has submitted an Administrative Consent Order and Agreement ("ACO") to the Municipal Authority with respect to alleged sanitary sewer overflows within the Township's sanitary sewer system or downgradient from the municipality; and

WHEREAS, certain provisions set forth in the ACO between ACHD and the Municipal Authority require participation or cooperation by the Township; and

WHEREAS, it is the desire of the Board of Commissioners of the Township of South Fayette to express their intent to cooperate with the Municipal Authority with respect to any undertaking which would require cooperation by the Township with respect to the proposed Administrative Consent Order.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF SOUTH FAYETTE, AS FOLLOWS:

1. The Commissioners of the Township of South Fayette do hereby express their willingness to cooperate with the Municipal Authority with respect to any undertaking which would require cooperation by the Township relative to any Administrative Consent Order and Agreement entered into between the Municipal Authority and the Allegheny County Health Department.

2. This Agreement to cooperate shall not enlarge, expand and / or alter in any way the Township's obligation to Municipal Authority.

3. This Resolution is to take effect upon the complete execution of the ACO.

4. Any Ordinance or Resolution, or portion thereof, conflicting with the provisions of this Resolution shall be and the same is hereby repealed, insofar as the same affects this Resolution.
