RESOLUTION NO. 24 of 2024

A RESOLUTION OF THE TOWNSHIP OF SOUTH FAYETTE, ALLEGHENY COUNTY, COMMONWEALTH OF PENNSYLVANIA, APPROVING THE TRANSFER OF LIQUOR LICENSE NO. R-6215 FROM GIANT EAGLE INC. TO GETGO OPERATING LLC LOCATED IN THE TOWNSHIP OF SOUTH FAYETTE, ALLEGHENY COUNTY, COMMONWEALTH OF PENNSYLVANIA.

WHEREAS, Act 141 of 2000 (the "Act"), which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of a Restaurant Liquor Licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the receiving municipality issues a resolution approving the transfer of the license from outside the municipality to premises situated inside the municipality; and

WHEREAS, amendments to the Liquor Code stipulate that prior to adoption of a resolution by the receiving municipality, at least one public hearing must be held for the purpose of permitting interested residents of the receiving municipality to offer comments regarding the transfer of the license into the municipality; and

WHEREAS, an application for transfer filed under the Act must include a copy of the resolution adopted by the municipality approving the transfer of the Restaurant Liquor License into the receiving municipality.

NOW THEREFORE, BE IT RESOLVED, that GETGO OPERATING LLC, has requested approval from the Board of Township Commissioners of the Township of South Fayette for the proposed transfer of Liquor License No. R-6215 to its facilities within the Township of South Fayette, Allegheny County with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that the Board of Township Commissioners of the Township of South Fayette, following a public hearing held pursuant to public notice on November 13, 2024 , finds that the transfer of Restaurant Liquor License Number R-6215 into the Township of South Fayette by GETGO OPERATING LLC will not adversely affect the welfare, health, peace and morals of the Township or its residents.

BE IT FURTHER RESOLVED, that the Board of Township Commissioners of the Township of South Fayette approve by adoption of this Resolution, the transfer of Liquor License No. R-6215 from GIANT EAGLE INC, Bridgeville GetGo #3641, 3029 Washington Pike, Bridgeville, PA 15017-1403 to GETGO OPERATING LLC, GetGo #3641, 3029 Washington Pike, Bridgeville, PA 15017-1403.

BE IT FURTHER RESOLVED, that the license transfer is subject to approval by the Pennsylvania Liquor Control Board.
